What you need to know

The Trust Deed makes provision for default beneficiaries. If the trustee fails to make a determination to distribute the income of the Trust in any year then the default beneficiary or beneficiaries from time to time will be entitled to the income.

Whether or not it is appropriate for there to be default beneficiaries and who they should be will depend on the circumstances of the beneficiaries from time to time. A nomination can be changed from time to time. If no default beneficiaries are nominated, some or all of the undistributed income will be treated as having been accumulated which may have adverse income tax consequences.
